Subject: NCI Bid Board Posting - Etiology of lung cancer in never smokers and special exposure cohorts .

The National Cancer Institute of Integrative Tumor Epidemiology Branch (ITEB) employs molecular pathology, somatic and germline genomics, and epidemiology to identify environmental and germline risk factors for cancer. The mission of ITEB is to conduct large-scale, international epidemiological research on cancer etiology and progression through integrative analyses of risk factors and tissue profiling to inform prevention and clinical strategies.

The objective of this procurement is to collaborate with several domestic and international sites to obtain deidentified biospecimens and data. The specific aim for this procurement is to retrieve, label and ship H&E slides, FFPE blocks, chest radiologic images (PET, CT and/or x-ray), radiology reports, plasma, DNA replenishment, and extracted RNA to NCI.

The National Cancer Institute plans to obtain data for primary lung cancer cases already selected for Sherlock-Lung through Nice University Hospital Center (UHC), 30 Avenue de la Voie Romaine, BP 69 06002 Nice Cedex 1. This is not a request for competitive quotation. However, if any interested party believes it can meet the attached requirements, it may submit a statement of capabilities. The capability statement must be in writing and must contain information and material in sufficient detail to allow NCI to determine if the party can fully meet this requirement. The capability statement must be received in the contracting office by 11:30 AM on November 13, 2020 ET. A determination by the Government not to compete this requirement based upon responses to this notice is solely within the discretion of the Government. Information received will be considered solely for the purpose of determining whether to conduct a competitive procurement.

Sole Source Justification:

UHC is one of the pilot sites for Sherlock-Lung. It has contributed fresh frozen tumor tissue and matched source of germline DNA for 103 primary lung cancer cases, which are necessary for the genomic analysis of lung cancer in non-smokers (LCINS; a primary aim of Sherlock-Lung). The study sought other biospecimens and data – including RNA, H&E slides, FFPE blocks, plasma, radiological images, and pathology reports – for these same 103 cases; information generated from these biospecimens and data needs to be evaluated together with the existing genomic information to develop an integrated molecular, histological, and radiological classification of LCINS (the other primary aim of Sherlock-Lung). In addition, the pilot genomic analysis has identified cancer stem cell-like features in some LCINS cases, including cases from UHC. It is of utmost importance to validate this important finding histologically using FFPE blocks from the same cases. Only UHC has the biospecimens and data for these 103 cases already included in Sherlock-Lung. Further, LCINS cases with such a complete set of biospecimens and data sought by Sherlock-Lung are rare even among sites participating in Sherlock-Lung; a sufficient number of cases with such a complete set of biospecimens and data is necessary to achieve the study aims. As such, UHC presents a unique source important for the success of Sherlock-Lung study.

1. TITLE

Etiology of lung cancer in never smokers and special exposure cohorts

2. BACKGROUND

General Description: *Sherlock-Lung* is a research project funded by the National Cancer Institute (NCI) Intramural Research Program at the Division of Cancer Epidemiology and Genetics (DCEG) aiming to investigate the etiology and progression of lung cancer in never-smokers from the general population, as well as from populations with substantial levels of special exposures through (1) an integrative genomic analysis, and (2) pathology, clinical, radiologic and epidemiologic assessment.

Given the rarity of lung cancer in non-smokers and the paucity of pathology material and other related data, NCI will collaborate with a number of domestic and international sites to obtain deidentified biospecimens and data. The Nice University Hospital Center (UHC) in France is one such site. Services are required from this site for the retrieval of biospecimens and associated data, processing of specimens, and shipment of data and materials.

2.1 OBJECTIVES

Project Objectives: The overall goals of the Integrative Tumor Epidemiology Branch (ITEB) *Sherlock-Lung* study are to collaborate with several domestic and international sites to obtain deidentified biospecimens and data. The specific aim for this procurement is to retrieve, label and ship H&E slides, FFPE blocks, chest radiologic images (PET, CT and/or x-ray), radiology reports, plasma, DNA replenishment, and extracted RNA to NCI.

3. SCOPE

In support of the NCI *Sherlock-Lung* study, UHC will retrieve, label and ship biospecimens to NCI.

4. CONTRACT REQUIREMENTS AND PERSONNEL QUALIFICATIONS (IF APPLICABLE)

4.1 Collaborators on the *Sherlock-Lung* project will retrieve selected biospecimens and associated data, process specimens, and ship data and materials as specified below.

4.1.1. Retrieval of selected biospecimens: Biospecimens selected for *Sherlock-Lung* must have been collected following minimum standards designated by NCI or NCI's designee. As requested by NCI or NCI's designee, UHC shall retrieve and ship the following biospecimens as specified below for each case of primary lung cancer selected for *Sherlock-Lung*:

- 1) DNA replenishment of 1 ug as requested (7 cases)
- 2) Extracted tumor and normal tissue RNA (28 cases)
 - RNA- preferred
 - a. Total Mass = 4ug [if measured by BioAnalyzer]
 - b. Total Mass = 6ug [if measured by NanoDrop]
 - c. Concentration of 100 – 200ng/ul
 - d. RIN \geq 7.0
 - RNA - minimum
 - a. Total Mass = 2ug [if measured by BioAnalyzer]
 - b. Total Mass = 3ug [if measured by NanoDrop]
 - c. Concentration of 100 – 200ng/ul
 - d. RIN \geq 5.0
- 3) H&E slides (to be scanned and returned) or H&E images from every tissue block for every tumor (98 cases)
- 4) FFPE blocks (at least one from tumor center and one from tumor periphery; additional, if available) or sections from FFPE blocks (103 cases)
 - (a) Blocks to be sectioned and remaining material returned
 - (b) Sections: (T) optimal 10 sections x 10 um, minimum 5 sections x 10 um; (N) optimal 20 sections x 10 um, minimum 10 sections x 10 um
- 5) Plasma (P), optimal \geq 7ml, minimum \geq 2 ml. (103 cases)

4.1.2. Shipment of biospecimens: UHC will provide a total of 103 primary lung cancer cases from confirmed never-smokers to NCI or NCI's designee. UHC shall label and ship biospecimens as designated by NCI or NCI's designee.

4.1.3. Provide associated data: UHC shall provide associated radiologic and pathology data. These include:

- All available de-identified chest CT, PET, and x-ray images (if CT and/or PET available, x-ray not required) for each case along with deidentified radiology reports or information abstracted from radiology reports.
- Deidentified pathology reports for each case or information abstracted from pathology reports.

4.2. Specific objectives of this procurement: For the current period of performance, as defined in the deliverable schedule, the subcontractor shall perform:

- a. Delivery of biospecimens per section 4.1.1 for 103 cases of primary lung cancers selected for *Sherlock-Lung*.
- b. Delivery of associated deidentified data for each case per section 4.1.3.

Inspection and Acceptance Criteria: Upon receipt of biospecimens and data, NCI or NCI's designee will review the deliverables to ensure that they conform to the requirements set forth in this Statement of Work. This will be completed within one month of the receipt of deliverable.

5. TYPE OF ORDER

This is a firm fixed price purchase order.

6. PERIOD OF PERFORMANCE:

The period of performance shall be 6 months starting from the date of award.

9.0 PAYMENT

Payment shall be made in 2 payments. Payment authorization requires submission and approval of invoices to the COR and NIH OFM in accordance with the attached payment provisions listed below.

(d) *Inspection/Acceptance.* The Contractor shall tender for acceptance only those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. The Government must exercise its postacceptance rights-

(1) Within a reasonable period of time after the defect was discovered or should have been discovered; and

(2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(e) *Excusable delays.* The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence, such as acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(f) *Termination for the Government's convenience.* The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges that the Contractor can demonstrate to the satisfaction of the Government, using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred that reasonably could have been avoided.

(g) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(h) *Warranty.* The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.

Representation Regarding Certain Telecommunications and Video Surveillance Services or Equipment (AUG 2020)

The Offeror shall not complete the representation at paragraph (d)(1) of this provision if the Offeror has represented that it “does not provide covered telecommunications equipment or services as a part of its offered products or services to the Government in the performance of any contract, subcontract, or other contractual instrument” in the provision at 52.204-26, Covered Telecommunications Equipment or Services—Representation, or in paragraph (v) of the provision at 52.212-3, Offeror Representations and Certifications-Commercial Items.

(a) *Definitions.* As used in this provision-

Backhaul, covered telecommunications equipment or services, critical technology, interconnection arrangements, reasonable inquiry, roaming, and substantial or essential component have the meanings provided in the clause 52.204-25, Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

(b) *Prohibition.* (1) Section 889(a)(1)(A) of the John S. McCain National Defense Authorization Act for Fiscal Year 2019 ([Pub. L. 115-232](#)) prohibits the head of an executive agency on or after August 13, 2019, from procuring or obtaining, or extending or renewing a contract to procure or obtain, any equipment, system, or service that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system. Nothing in the prohibition shall be construed to—

(i) Prohibit the head of an executive agency from procuring with an entity to provide a service that connects to the facilities of a third-party, such as backhaul, roaming, or interconnection arrangements; or

(ii) Cover telecommunications equipment that cannot route or redirect user data traffic or cannot permit visibility into any user data or packets that such equipment transmits or otherwise handles.

(2) Section 889(a)(1)(B) of the John S. McCain National Defense Authorization Act for Fiscal Year 2019 ([Pub. L. 115-232](#)) prohibits the head of an executive agency on or after August 13, 2020, from entering into a contract or extending or renewing a contract with an entity that uses any equipment, system, or service that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system. This prohibition applies to the use of covered telecommunications equipment or services, regardless of whether that use is in performance of work under a Federal contract. Nothing in the prohibition shall be construed to—

(i) Prohibit the head of an executive agency from procuring with an entity to provide a service that connects to the facilities of a third-party, such as backhaul, roaming, or interconnection arrangements; or

(ii) Cover telecommunications equipment that cannot route or redirect user data traffic or cannot permit visibility into any user data or packets that such equipment transmits or otherwise handles.

(c) *Procedures.* The Offeror shall review the list of excluded parties in the System for Award Management (SAM) (<https://www.sam.gov>) for entities excluded from receiving federal awards for “covered telecommunications equipment or services.”

(d) *Representations.* The Offeror represents that—

(1) It will, will not provide covered telecommunications equipment or services to the Government in the performance of any contract, subcontract or other contractual instrument resulting from this solicitation. The Offeror shall provide the additional disclosure information required at paragraph (e)(1) of this section if the Offeror responds “will” in paragraph (d)(1) of this section; and

(2) After conducting a reasonable inquiry, for purposes of this representation, the Offeror represents that—

It does, does not use covered telecommunications equipment or services, or use any equipment, system, or service that uses covered telecommunications equipment or services. The Offeror shall provide the additional disclosure information required at paragraph (e)(2) of this section if the Offeror responds “does” in paragraph (d)(2) of this section.

(e) *Disclosures.* (1) Disclosure for the representation in paragraph (d)(1) of this provision. If the Offeror has responded “will” in the representation in paragraph (d)(1) of this provision, the Offeror shall provide the following information as part of the offer:

(i) For covered equipment—

(A) The entity that produced the covered telecommunications equipment (include entity name, unique entity identifier, CAGE code, and whether the entity was the original equipment manufacturer (OEM) or a distributor, if known);

(B) A description of all covered telecommunications equipment offered (include brand; model number, such as OEM number, manufacturer part number, or wholesaler number; and item description, as applicable); and

(C) Explanation of the proposed use of covered telecommunications equipment and any factors relevant to determining if such use would be permissible under the prohibition in paragraph (b)(1) of this provision.

(ii) For covered services—

(A) If the service is related to item maintenance: A description of all covered telecommunications services offered (include on the item being maintained: Brand; model number, such as OEM number, manufacturer part number, or wholesaler number; and item description, as applicable); or

(B) If not associated with maintenance, the Product Service Code (PSC) of the service being provided; and explanation of the proposed use of covered telecommunications services and any factors relevant to determining if such use would be permissible under the prohibition in paragraph (b)(1) of this provision.

(2) Disclosure for the representation in paragraph (d)(2) of this provision. If the Offeror has responded “does” in the representation in paragraph (d)(2) of this provision, the Offeror shall provide the following information as part of the offer:

(i) For covered equipment—

(A) The entity that produced the covered telecommunications equipment (include entity name, unique entity identifier, CAGE code, and whether the entity was the OEM or a distributor, if known);

(B) A description of all covered telecommunications equipment offered (include brand; model number, such as OEM number, manufacturer part number, or wholesaler number; and item description, as applicable); and

(C) Explanation of the proposed use of covered telecommunications equipment and any factors relevant to determining if such use would be permissible under the prohibition in paragraph (b)(2) of this provision.

(ii) For covered services—

(A) If the service is related to item maintenance: A description of all covered telecommunications services offered (include on the item being maintained: Brand; model number, such as OEM number, manufacturer part number, or wholesaler number; and item description, as applicable); or

(B) If not associated with maintenance, the PSC of the service being provided; and explanation of the proposed use of covered telecommunications services and any factors relevant to determining if such use would be permissible under the prohibition in paragraph (b)(2) of this provision.
