A determination by the Government not to compete this requirement based upon responses to this notice is solely within the discretion of the Government. Information received will be considered solely for the purpose of determining whether to conduct a competitive procurement

STATEMENT OF WORK

1.0 SCOPE

Contractor to provide software package for **Site license for FlowJo flow cytometry analysis software 50 seats.**

The NCI Experimental Transplantation and Immunology Branch Flow Cytometry Facility provides flow and image cytometry services to investigators in multiple NCI Branch's. The core is required to maintaining an up-to-date array of cell analysis and separation instrumentation for its investigators who are continuing to fulfill the mission on reducing the burden of cancer through exploration, discover and translation.

Essential to the both the operation of the core facility and the research needs of the ETIB is access to a modern flow cytometry software package. Since 2009, the ETIB has used FlowJo, a comprehensive flow cytometry analysis software package offered by Tree Star software. This software is uniquely suited to the batch analysis needs of the ETIB, and most of the analysis needs of the Branch are now dependent on this package. The Branch currently has a license for 30 copies of this package, installed on the computers of ETIB investigators and administered by the Core. Since virtually all of ETIB data is currently embedded in the FlowJo environment, it is critical to continue to use this software package for routine analysis.

Only the FlowJo software package is appropriate for the uses of the ETIB. The Branch has a eleven-year history with this software, and virtually all of the flow cytometry data generated by the Branch is now imbedded in FlowJo analysis workspaces. ETIB investigators are also well-trained in FlowJo. To switch to a new software package would constitute an undue burden on ETIB investigators and the Core, requiring complete retooling of their analysis methods.

Site license will include (1) full customer support via phone or e-mail for the duration of the license, (2) unlimited upgrades for the duration of the license, (3) unlimited flexibility to add/remove individuals from the site license, managed on-site by the Core manager.

All maintenance services shall be performed in accordance with the manufacturer's standard commercial maintenance practices. Lasers, detectors, electronics and fluidic components will be covered by this service contract. The contractor shall provide Software Service in accordance with the manufacturer's latest established service procedures, to include telephone access to technical support for use of program software and troubleshooting of the operating systems, at no additional cost to the Government. The contractor shall receive advance approval for the installation of all software updates and revisions from the Government. Defective software shall be replaced at no additional cost to the government.

Contractor to provide access and support for a 50 seat FlowJo site license. All services shall be performed in accordance with the manufacturer's standard commercial software support practices. The contractor shall receive advance approval for the installation of all software updates and revisions from the Government. Defective software shall be replaced at no additional cost to the government.

All maintenance services shall be performed in accordance with the manufacturer's standard commercial maintenance practices. The contractor will provide internet-verified access to FlowJo for the stated period, for up to 50 individuals (seat). Software will be compatible with both PC and Mac computers. Site license will include (1) full customer support via phone or e-mail for the duration of the license, (2) unlimited upgrades for the duration of the license, (3) unlimited flexibility to add/remove individuals from the site license, managed on-site by the Core manager.

2.0 TYPE OF ORDER

STATEMENT OF WORK

This is a firm fixed-price purchase order.

3.0 SPECIAL ORDER REQUIREMENTS

3.1 PREVENTIVE MAINTENANCE

Contractor to provide access and support for a 50 seat FlowJo site license. All services shall be performed in accordance with the manufacturer's standard commercial software support practices. The contractor shall receive advance approval for the installation of all software updates and revisions from the Government. Defective software shall be replaced at no additional cost to the government.

3.2 EMERGENCY SERVICE

Emergency software support shall be provided during the term of this contract at no additional cost to the government. Upon receipt of notice that software is not functioning properly the Contractor shall provide response of qualified service representatives to restore the software to normal and efficient operating condition.

3.3 REPLACEMENT PARTS

Replacement parts do not apply under this SOW.

3.4 SOFTWARE UPDATES/SERVICE

The Contractor shall provide Software Service and updates in accordance with the manufacturer's latest established service procedures, to include telephone access to technical support for use of program software and trouble shooting of the operating systems, at no additional cost to the Government. The contractor shall receive advance approval for the installation of all software updates and revisions from the Government. Defective software shall be replaced at no additional cost to the government.

The contractor shall provide Software Service in accordance with the manufacturer's latest established service procedures, to include telephone access to technical support for use of program software and troubleshooting of the operating systems, at no additional cost to the Government. The contractor shall receive advance approval for the installation of all software updates and revisions from the Government. Defective software shall be replaced at no additional cost to the government.

3.5 SERVICE EXCLUSIONS

The Contractor shall not be responsible for any repairs necessitated by abuse, neglect, vandalism, Acts of God, fire or water. These repairs shall be the subject of a separate purchase order and shall not be performed under this contract.

3.6 PERIOD OF PERFORMANCE

The base period of performance shall be for twelve (12) months from 06/01/2021 thru 05/30/2022.

3.7 PERSONNEL QUALIFICATIONS

5.0 PAYMENT

Payment shall be made yearly. Payment authorization requires submission and approval of invoices to the COR and NIH OFM, in accordance with the payment provisions listed below:

The following clause is applicable to all Purchase Orders, Task or Delivery Orders, and Blanket Purchase Agreement (BPA) Calls: PROMPT PAYMENT (JUL 2013) FAR 52.232-25. Highlights of this clause and NIH implementation requirements follow:

I INVOICE REQUIREMENTS

- A. An invoice is the Contractor's bill or written request for payment under the contract for supplies delivered or services performed. II. INVOICE PAYMENT

- (4) For equipment, the entity that produced the covered telecommunications equipment (include entity name, unique entity identifier, CAGE code, and whether the entity was the OEM or a distributor, if known).

(D) Specified in the design of a building or work, or incorporated during its construction, renovation, or maintenance).

(xv) [52.223-20](#), Aerosols (JUN 2016) (E.O. 13693) (Applies to contracts for products that may contain high global warming potential hydrofluorocarbons as a propellant or as a solvent; or contracts for maintenance or repair of electronic or mechanical devices).

(d) *Inspection/Acceptance.* The Contractor shall tender for acceptance only those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. The Government must exercise its postacceptance rights-

(1) Within a reasonable period of time after the defect was discovered or should have been discovered; and

(2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(e) *Excusable delays.* The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence, such as acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(f) *Termination for the Government's convenience.* The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges that the Contractor can demonstrate to the satisfaction of the Government, using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred that reasonably could have been avoided.

(g) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(h) *Warranty.* The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.
