Subject: NCI Bid Board Posting – Maintenance agreement for TrueBeam Essentials and Calypso Essentials H192104, HCL1171 for ROB.

The Radiation Oncology Branch (ROB) The TrueBeam radiotherapy system consists of a base unit, peripheral devices, and operating software. This system is used to treat patients with radiation in accordance with approved clinical trial protocols in the Radiation Oncology Branch clinic. Because of the urgency of this requirement, only one source will be solicited. The Service and Maintenance of Truebeam Linear Accelerator H192104 must be performed starting Aug 3, 2021 and lasting to no longer than Aug 30, 2021. If the required performance date is not met, any interruption of the functioning of the Truebeam Linear Accelerator could result in either inaccurate delivery of dose and/or location of the radiation treatment, or interruption of the patient's treatment schedule, which could have negative health consequences for the patient. In addition, only Varian is able to install software upgrades and firmware updates.

This is not a request for competitive quotation. However, if any interested party believes it can meet the attached requirements, it may submit a statement of capabilities. The capability statement must be in writing and must contain information and material in sufficient detail to allow NCI to determine is the party can fully meet this requirement. The capability statement must be received in the contracting office by 11:30 AM on July 29, 2021 ET. A determination by the Government not to compete this requirement based upon responses to this notice is solely within the discretion of the Government. Information received will be considered solely for the purpose of determining whether to conduct a competitive procurement.

**Sole Source Justification:**

Varian Medical Systems is the sole provider for the Truebeam Linear Accelerator. As such, their personnel are intimately familiar with the operations, repair, and maintenance of the Truebeam and its associated sub systems. Additionally, Varian has a 24-hour emergency hotline that can help quickly resolve some issues. They also are able to quickly deliver and replace any broken components of the Truebeam, usually within 24 hours, due to access to a large supply of components.

## STATEMENT OF WORK

### 1.0 SCOPE

The Contractor shall provide all labor, material, software and firmware updates, and equipment necessary to maintain and provide preventive maintenance for the following sets of equipment:

The TrueBeam radiotherapy system consists of a base unit, peripheral devices, and operating software. This system is used to treat patients with radiation in accordance with approved clinical trial protocols in the Radiation Oncology Branch clinic. All maintenance services shall be performed on-site in accordance with the manufacturer’s standard commercial maintenance practices.

### 2.0 TYPE OF ORDER

This is a firm fixed-price purchase order.

### 3.0 SPECIAL ORDER REQUIREMENTS

#### 3.1 PREVENTIVE MAINTENANCE

Technically qualified factory-trained personnel shall perform Service. Service shall consist of a thorough cleaning, calibration, adjusting, inspection, and testing of all equipment in accordance with the manufacturer’s latest established service procedures. All equipment shall be operationally tested through at least one (1) complete operating cycle at the end of the preventive maintenance inspection to assure optimum and efficient performance.

#### 3.2 EMERGENCY SERVICE

## STATEMENT OF WORK

On-site, emergency repair service visit shall be provided during the term of this contract at no additional cost to the government. Emergency service shall be provided during normal working hours, Monday through Friday excluding Federal Holidays. Upon receipt of notice that any part of the equipment is not functioning properly the Contractor shall within provide a one (1) hour initial response with a four (4) hour on-site response a qualified factory-trained service representative to inspect the equipment and perform all repairs and adjustments necessary to restore the equipment to normal and efficient operating condition. Emergency service calls shall not replace the necessity for planned preventative maintenance. All labor and travel will be included.

### 3.3 REPLACEMENT PARTS

The Contractor shall furnish all required replacement parts at no additional cost to the Government, with the exception of consumables. Parts shall be new to original equipment specifications. Parts will be delivered the earliest next day.

### 3.4 SOFTWARE UPDATES/SERVICE

The Contractor shall provide Software Service and updates, including upgrades and firmware updates, in accordance with the manufacturer's latest established service procedures. This is to also include telephone access to technical support for use of program software and trouble shooting of the operating systems, at no additional cost to the Government. The contractor shall receive advance approval for the installation of all software updates and revisions from the Government. Software shall be installed remotely or on-site as necessary. Defective software shall be replaced at no additional cost to the government.

The Contractor shall provide unlimited technical support via phone, email, and internet service portal during Standard Hours for trouble-shooting the instrument. The Contractor shall be able to provide remote diagnostics and support for the system. The Contractor shall provide unlimited clinical application support for questions related to operation of the system via phone, email, and internet service portal during Standard Hours. All remote support shall be staffed by certified factory-trained engineers.

### 3.5 SERVICE EXCLUSIONS

The Contractor shall not be responsible for any repairs necessitated by abuse, neglect, vandalism, Acts of God, fire or water. These repairs shall be the subject of a separate purchase order and shall not be performed under this contract.

### 3.6 PERIOD OF PERFORMANCE

The period of performance shall be from Aug 3, 2021 to Aug 30, 2021.

### 3.7 PERSONNEL QUALIFICATIONS

## STATEMENT OF WORK

Personnel shall have a minimum of two (2) years factory training and experience in the servicing of the TrueBeam radiation therapy system and software covered by this contract. All primary service personnel shall have at least one backup support person with at least the same level of expertise.

### **5.0 PAYMENT**

## II. INVOICE PAYMENT

(d) *Inspection/Acceptance.* The Contractor shall tender for acceptance only those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. The Government must exercise its postacceptance rights-

(1) Within a reasonable period of time after the defect was discovered or should have been discovered; and

(2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(e) *Excusable delays.* The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence, such as acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(f) *Termination for the Government's convenience.* The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges that the Contractor can demonstrate to the satisfaction of the Government, using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred that reasonably could have been avoided.

(g) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(h) *Warranty.* The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.
