Subject: NCI Bid Board Posting – High quality complete observation environment with built-in stimuli is necessary to explore the behavioral effects of the tumor and treatment in a mouse model for NOB.

The Neuro-Oncology Branch (NOB) of CCR is performing translational researches on brain tumors, using biological, biochemical, pathological, and immunological methods in vitro and in vivo, to understand the biological underpinnings of symptoms and toxicity related to both the tumor and therapy. A high-quality complete observation environment with built-in stimuli is necessary to explore the behavioral effects of the tumor and treatment in a mouse model. The PhenoTyper home cage set up is designed for the animal to live in the home cage environment and has full integration of the test environment and video equipment to allow data collection on the behavioral effects over time. We have purchased and used the PhenoTyper home cage monitoring system, which has well met the on-going translational research needs, and are requesting to purchase another one for the increased animal experiments from Noldus Information Technology, the sole manufacturer and supplier.

This is not a request for competitive quotation. However, if any interested party believes it can meet the attached requirements, it may submit a statement of capabilities. The capability statement must be in writing and must contain information and material in sufficient detail to allow NCI to determine if the party can fully meet this requirement. The capability statement must be received in the contracting office by 11:30 AM on July 31, 2021 ET. A determination by the Government not to compete this requirement based upon responses to this notice is solely within the discretion of the Government. Information received will be considered solely for the purpose of determining whether to conduct a competitive procurement.

Sole Source Justification:

Noldus Information Technology, an international well-known high-technology company, develops and delivers innovative software and hardware solutions and services for the measurement and analysis of behavior. The PhenoTyper home cage environment can be used for a variety of tests, such as novel object, social interactions, 24 hour monitoring, operant conditioning, all of which completely integrates with EthoVision XT software for a seamless product. This is the only cage of its kind designed to provide the ability to track and analyze the movement, activity and behavioral in an arena with automatic detection and analysis of data, which would not be feasible using researcher observation only.

1.0 TITLE

PhenoTyper mouse home cage monitoring system

2.0 BACKGROUND

The Neuro-Oncology Branch (NOB) of the CCR, NCI, is performing translational researches on brain tumors, especially on the most malignant form - glioblastoma, using biological, biochemical, pathological, and immunological methods to develop novel therapeutics for the patients with brain tumors. Dr Terri Armstrong, a senior PI of NOB, has been working on the Patient Outcome project for patients with CNS tumors. Using mouse brain tumor model, we are studying the animal behavior under the disease condition as it is one of the critical experiments for our on-going research. By using the PhenoTyper mouse home cage monitoring system, exciting data has been obtained. Increased animal experiments are approved to perform in our model, and therefore a new set of PhenoTyper system is needed to be purchased.

(d) *Inspection/Acceptance.* The Contractor shall tender for acceptance only those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. The Government must exercise its postacceptance rights-

(1) Within a reasonable period of time after the defect was discovered or should have been discovered; and

(2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(e) *Excusable delays.* The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence, such as acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(f) *Termination for the Government's convenience.* The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges that the Contractor can demonstrate to the satisfaction of the Government, using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred that reasonably could have been avoided.

(g) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(h) *Warranty.* The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.
