Subject: NCI Bid Board Posting - Data and analysis of 64 cell samples by mass spectro-metry analysis for RBB.

The Radiation Biology Branch (RBB) has determined that K-RAS inhibition can radiosensitize tumor cell lines and we are interested in determining the exact mechanism of this sensitization. Often times inhibiting important signal transduction pathways has important effects on tumor cell metabolism which may explain the effectiveness of the K-RAS inhibitors. HMT mass spectrometry method can simultaneously measure the concentrations of 116 metabolites and also various pyrimidines which may provide important mechanism of radiosensitization.

This is not a request for competitive quotation. However, if any interested party believes it can meet the attached requirements, it may submit a statement of capabilities. The capability statement must be in writing and must contain information and material in sufficient detail to allow NCI to determine is the party can fully meet this requirement. The capability statement must be received in the contracting office by 11:30 AM on July 29, 2021 ET. A determination by the Government not to compete this requirement based upon responses to this notice is solely within the discretion of the Government. Information received will be considered solely for the purpose of determining whether to conduct a competitive procurement.

**Sole Source Justification:**

Radiation Biology Branch, Tumor Biology Section is currently conducting experiments using in vivo models to identify various bio-markers which may indicate the mechanisms of drug and radiation sensitization. We use these markers to quantify alterations in cell signaling and repair pathways. Recently we have begun to analysis metabolic pathways from molecules isolated tumor and normal cells treated with specific Ras inhibitors. The metabolites identified by the Human Metabolome Technologies MS-HPLC analysis (116 different metabolites) can help identify specific metabolic pathways being altered by Ras inhibition in human tumor cell lines.

## **STATEMENT OF WORK (SOW)**

### **1.0 TITLE**

*Comparison of 116 metabolites from human tumor cell lines treated with K-RAS inhibitors.*

### **2.0 BACKGROUND**

The RBB Branch has a long term project investigating the effect of inhibiting various signal transduction pathways on the radiation sensitivity of various human tumor cell lines. It is thought that inhibition of K-RAS can alter radiation sensitivity and thus finding and using drugs which can specifically target the K-RAS pathway is an important area of research.

### **2.1 OBJECTIVE**

The objectives of this procurement are:

*1. Study any metabolic changes in multiple human tumor cell lines after K-RAS inhibition.*

### **3.0 SCOPE**

The RBB has determined that K-RAS inhibition can radiosensitize tumor cell lines and we are interested in determining the exact mechanism of this sensitization. Often times inhibiting important signal transduction pathways has important effects on tumor cell metabolism which may explain the effectiveness of the K-RAS inhibitors. HMT mass spectrometry method can simultaneously measure the concentrations of 116 metabolites and also various pyrimidines which may provide important mechanism of radiosensitization.

### **4.0 CONTRACT REQUIREMENTS/ AND PERSONNEL QUALIFICATIONS**

1. Careful storage of received samples (64 total).
2. Careful preparation of tissue samples for CE-MS (capillary electrophoresis – mass spectrometry)
3. Absolute concentration of 116 target metabolites
4. Determination of pyrimidines: UTP, CTP, dGTP, dATP, dCTP, and dTTP for 64 samples.
4. Metabolic parameters such as glycolysis, TCA cycle, PPP and amino acid turnover, GSH, purines and pyrimidines to be determined.
5. Basic and multivariate statistical analysis results
6. Poster-sized pathway map

### **5.0 TYPE OF ORDER**

This is a firm fixed price contract – the contractor must provide a firm price for all services required now.

### 6.0 PERIOD OF PERFORMANCE

The period of performance shall be for 24 months beginning from the date of award.

### 7.0 PLACE OF PERFORMANCE

Work will be performed both at the HMT laboratories.

In order to facilitate the prompt payment of invoices, it is recommended that the vendor submit a photocopy of the invoice to the "Consignee" designated for the acquisition in blocks 6A – 6E of the face page of the Order/Award document.

### II. INVOICE PAYMENT

(d) *Inspection/Acceptance.* The Contractor shall tender for acceptance only those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. The Government must exercise its postacceptance rights-

(1) Within a reasonable period of time after the defect was discovered or should have been discovered; and

(2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(e) *Excusable delays.* The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence, such as acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(f) *Termination for the Government's convenience.* The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges that the Contractor can demonstrate to the satisfaction of the Government, using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred that reasonably could have been avoided.

(g) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(h) *Warranty.* The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.
