Subject: NCI Bid Board Posting – One-year Preventive Maintenance contract for the period September 21, 2021 to September 20, 2022. Coverage includes the SA3800 Spectral Flow Cytometry Cell Analyzer, S/N 2000020 with four lasers and one Computer Workstation.

The objective of this procurement is to assist the Flow Cytometry Core Facility in Building 37, who supports the CCR scientific research community, by providing instrumentation and expertise to perform state-of-the art cell analysis and sorting. The laboratory currently has five cell analyzers and four cell sorters, serving over 200 scientists every year. They need to be kept in optimal condition with scheduled preventive maintenance and, if out of service, need to be repaired as quickly and efficiently as possible.

The National Cancer Institute plans to obtain a preventative maintenance contract from Sony Biotechnology, San Jose, CA. This is not a request for competitive quotation. However, if any interested party believes it can meet the attached requirements, it may submit a statement of capabilities. The capability statement must be in writing and must contain information and material and enough detail to allow NCI to determine if the party can fully meet this requirement. The capability statement must be received in the contracting office by 11:30 AM on July 8, 2020 ET. A determination by the Government not to compete this requirement based upon responses to this notice is solely within the discretion of the Government. Information received will be considered solely for the purpose of determining whether to conduct a competitive procurement.

Sole Source Justification:

*Sony Biotechnology, Inc is the developer and sole manufacturer of the SA3800 Spectral Flow Cytometry Cell Analyzer and the only vendor that has Field Service Engineers specifically trained to perform preventative maintenance, instrument repairs and software upgrades on the SA3800 Spectral Flow Cytometry Cell Analyzer using the required proprietary replacement parts or computer software. No other vendors currently provide this service for the SA3800 Spectral Flow Cytometry Cell Analyzer. This makes Sony Biotechnology, Inc the only available source.*

# STATEMENT OF NEED (SON)

## 1.0 TITLE

One-year service maintenance contract for the SA3800 Spectral Flow Cytometry Cell Analyzer.

## 2.0 BACKGROUND

Contractor shall provide all labor, parts, material and equipment for the on-going and preventive maintenance for government-owned Sony Biotechnology, Inc SA3800 spectral flow cytometry cell analyzer. This is a one-year Service Maintenance Contract for the period of September 21, 2021 to September 20, 2022. All maintenance service shall be performed in accordance with the manufacturer's standard commercial maintenance practices.

## 3.0 TYPE OF ORDER

This is a Firm Fixed-Price Purchase Order.

## 4.0 SPECIAL ORDER REQUIREMENTS

### 4.1 PRODUCT FEATURES/SALIENT CHARACTERISTICS

The following product features/characteristics are required for this requirement:

- Contractor shall perform annual preventive maintenance inspections (PMI) on the SA3800 Spectral during the 1-year contract period. Technically qualified factory-trained personnel or service providers authorized by Sony Biotechnology, Inc shall perform service. Service shall consist of thorough cleaning, calibration, adjusting, inspection, and testing of all equipment in accordance with the manufacturer's latest technical specifications. All equipment shall be operationally tested through at least one (1) complete operating cycle at the end of the preventive maintenance inspection to assure optimum and efficient performance. Cost for labor, travel, and two preventive maintenance kits are included.
- Emergency repair services shall be provided on an unlimited basis during the term of this contract at no additional cost to the government. Emergency repair services shall be provided during normal business hours, Monday through Friday excluding Federal Holidays. Upon receipt of notice that any part of an instrument is not functioning properly the Contractor shall within forty-eight (48) hours, furnish a qualified factory-trained service representative to inspect the equipment and perform all repairs and adjustments necessary to restore the equipment to normal and efficient operating condition. Unlimited telephone support for instrumentation, applications, and reagents shall be provided from 8:00 AM to 12:00 AM EST Monday through Friday. Emergency service calls shall not replace the necessity for scheduled PMIs
- The contractor shall furnish all required replacement parts including shipping costs, with the exception of consumable parts, at no additional cost to the Government. Parts shall be new or re-manufactured to original equipment specifications.

### 4.3 TRAINING

Service personnel shall have a minimum of three (3) years factory training and experience in the servicing of Sony SA3800 or similar spectral flow cytometry instruments and ancillary devices as covered by this contract. All primary service personnel shall have at least one backup support person with at least the same level of expertise on the equipment covered by this contract.

### 5.0 PAYMENT

Payment shall be made quarterly in arrears. Payment authorization requires submission and approval of invoices to the COR and NIH OFM, in accordance with the payment provisions listed below:

- A. An invoice is the Contractor's bill or written request for payment under the contract for supplies delivered or services performed. In order to facilitate the prompt payment of invoices, it is recommended that the vendor submit a photocopy of the invoice to the "Consignee" designated for the acquisition in blocks 6A – 6E of the face page of the Order/Award document.

## II. INVOICE PAYMENT

- A. Except as indicated in paragraph B., below, the due date for making invoice payments by the designated payment office shall be the later of the following two events:
  1. The 30th day after the designated billing office has received a proper invoice.
  2. The 30th day after Government acceptance of supplies delivered or services performed.
- B. The due date for making invoice payments for meat and meat food products, perishable agricultural commodities, dairy products, and edible fats or oils, shall be in accordance with the Prompt Payment Act, as amended.

(d) *Inspection/Acceptance.* The Contractor shall tender for acceptance only those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. The Government must exercise its postacceptance rights-

(1) Within a reasonable period of time after the defect was discovered or should have been discovered; and

(2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(e) *Excusable delays.* The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence, such as acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(f) *Termination for the Government's convenience.* The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges that the Contractor can demonstrate to the satisfaction of the Government, using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred that reasonably could have been avoided.

(g) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(h) *Warranty.* The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.
