Subject: NCI Bid Board Posting – Upgrade Kit for ChemiDoc to ChemiDoc MP

Among the defining concepts of the Genetics Branch is one that underlies its basic research focus and others that form the foundation of its clinical and translational research activities. The concept that underlies basic research is that cancer is a genetic disease caused by genetic instability. That instability is a function of all the inherited and acquired effects that mediate plasticity and alterability at the level of DNA. The success of molecular genetics over the past two decades has been the identification of genes involved in pathways of growth and development, and the identification of the mechanisms by which the normal regulation and/or products of these genes are altered in cancer. The elucidation of the necessary and sufficient factors that govern genetic instability, the description of the common and disparate themes among different types of instability, and the cataloging of distinct patterns of gene expression in tumors compared to the normal tissues from which they arise are within the purview and distinct perspective of this branch. There is, in addition, a clinical/translational mantle that this branch is called upon to shoulder.

# STATEMENT OF NEED (SON)

## 1.0 TITLE

Upgrade Kit for ChemiDoc to ChemiDoc MP

## 2.0 BACKGROUND

The ChemiDoc acquired a few years ago had limited imaging capacity in terms of the range of fluorophores detection. This upgrade allows multiplexing fluorophore which meets the requirement of Western blot analysis on human research subject. The upgrade will also save time, money and enable to perform experiments when the protein sample size is limited. Since this is an upgrade, there is no other sources that can meet our needs.

## 3.0 TYPE OF ORDER

This is a Firm Fixed-Price Purchase Order.

## 4.0 SPECIAL ORDER REQUIREMENTS

### 4.1 PRODUCT FEATURES/SALIENT CHARACTERISTICS

This upgrade is featured by installation of additional fluorescence light filters, detectors and software.

### 4.2 DELIVERY / INSTALLATION

The upgrade will be installed on ChemiDoc imaging system (serial number 733BR2027) located in Bldg. 41 Rm. B900. The delivery will not be delayed once this purchase is awarded.

### 4.3 TRAINING

Very minimum training is required since the use of the application will remain the same as for the equipment before the upgrade. However, the training will be provided by the vendor upon the installation of the upgrade.

## **52.204-24 Representation Regarding Certain Telecommunications and Video Surveillance Services or Equipment.**

In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(h) *Warranty.* The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.

(End of clause)
