Subject: NCI Bid Board Posting – service contract renewal for Delta Vision Elite microscopy system

The research program in the Laboratory of Receptor Biology and Gene Expression (LRBGE) concerns the elucidation of mechanisms involved in the regulation of genetic expression in eukaryotic cells, the architecture and organization of the mammalian nucleus, and the identification of genes and regulatory processes involved in modulated states of expression during oncogenesis.

Healthcare Delta Vision Elite Optical Sectioning microscope from former Applied Precision, LLC, currently acquired by Leica Microsystems Inc. The NIH/NCI/CCR users use this system for the high-quality imaging and 3D reconstruction of the fixed and live samples of cancer cells and tissues, with a quality superior to common confocal microscopes. The system is heavily used by the Core users and even one day of lost time due to shutdown of the system is unacceptable. Due to heavy usage the system experiences frequent breakdowns impossible to fix w/o the service contract. The whole system requires professional maintenance including scheduled service visits and part replacement. Thus, the service contract is crucial to the function of CCR/LRBGE/OMC of providing a high-end non-confocal imaging of cancer cells and tissues to CCR, NCI and NIH community of researchers.

Sole Source Justification:

Leica/Applied Precision is the only source that holds the patents for the unique Delta Vision system and provides fast response (within 3 days) custom care, repairs and preventive maintenance. There is no other source that provides this type of custom care, which is crucial to our role in providing a high-end non-confocal imaging of cancer cells and tissues to CCR, NCI and NIH community of researchers.

## STATEMENT OF WORK

1. SCOPE: Contractor shall provide all labor, material and equipment necessary to maintain and provide preventive maintenance for a government-owned Delta Vision Elite Optical Sectioning Microscope, S/N cn84829 / Isdv3131379ca, NIH property # 02007816 for the period of performance (POP) from Nov 17, 2021 through Nov 16, 2022. All maintenance service shall be performed on-site in accordance with the manufacturer's standard commercial maintenance practices.

2. PREVENTIVE MAINTENANCE: Contractor shall perform one (1) preventive maintenance inspections (PMI) during the contract period. Technically qualified factory-trained personnel shall perform the PMI Service. Service shall consist of a thorough cleaning, calibration, adjusting, inspection, lubrication and testing of all equipment in accordance with the manufacturer's latest established service procedures. All equipment shall be operationally tested through at least one (1) complete operating cycle at the end of the preventive maintenance inspection to assure optimum and efficient performance.

3. EMERGENCY SERVICE: Emergency repair services shall be provided on an unlimited basis during the term of this contract at no additional cost to the government. Emergency service shall be provided during normal working hours, Monday through Friday excluding Federal Holidays. Upon receipt of notice that any part of the equipment is not functioning properly the Contractor shall within twenty-four (24) hours furnish a qualified factory-trained service representative to inspect the equipment and perform all repairs and adjustments necessary to restore the equipment to normal and efficient operating condition. Emergency service calls shall not replace the necessity for scheduled PMIs.

The contractor shall provide unlimited technical support hot-line number for telephonic trouble-shooting the instrument, reagents and applications during normal working hours, except Federal holidays.

4. REPLACEMENT PARTS: The contractor shall furnish all required replacement parts at no additional cost to the Government, with the exception of consumables. Parts shall be new or re-manufactured to original equipment specifications.

5. SOFTWARE UPDATES/SERVICE: The contractor shall provide Software Service and updates in accordance with the manufacturer's latest established service procedures, to include telephone access to technical support for use of program software and trouble shooting of the operating systems, at no additional cost to the Government. The contractor shall receive advance approval for the installation of all software updates and revisions from the Government. Defective software shall be replaced at no additional cost to the government.

## STATEMENT OF WORK

6. SERVICE EXCLUSIONS: The contractor shall not be responsible for any repairs necessitated by abuse, neglect, vandalism, Acts of God, fire or water. These repairs shall be the subject of a separate purchase order and shall not be performed under this contract.

7. PERIOD OF PERFORMANCE: Period of Performance shall be for twelve (12) months from 17 Nov 2021 through 16 Nov 2022.

8. PERSONNEL QUALIFICATIONS: Personnel shall have a minimum of three (3) years factory training and experience in the servicing of the Delta Vision Optical Sectioning Microscope and DV sCMOS 4.2 camera as covered by this contract. All primary service personnel shall have at least one backup support person with at least the same level of expertise on the equipment covered by this contract.
