Subject: NCI Bid Board Posting – to purchase Cytokine & Chemokine Convenience 36-Plex Mouse ProcartaPlex™ Panel 1A and Cytokine & Chemokine Convenience 34-Plex Human ProcartaPlex™ Panel 1A.

The Laboratory of Human Carcinogenesis (LHC) has a multifaceted research program integrating basic, translational, clinical, and population research, with a major focus on common and lethal human cancers that include tumors of the breast, colon, esophagus, liver, lung, pancreas and prostate. LHC studies utilize a Precision Medicine Strategy. It's main objectives are to conduct investigations that assess: (1) Mechanisms of carcinogenesis including the cellular functions of cancer driving genes; (2) experimental approaches in biological systems for the extrapolation of carcinogenesis data and mechanisms from in vitro models and experimental animals to humans; (3) molecular integrative epidemiology of human cancer risk; and (4) cancer biomarkers of diagnosis, prognosis, and therapeutic outcome.

The Laboratory of Human Carcinogenesis (LHC) of the NCI, NIH has ongoing experimental plans that require the purchase of both ThermoFisher Cytokine & Chemokine Convenience 36-Plex Mouse ProcartaPlex™ Panel 1A and Cytokine & Chemokine Convenience 34-Plex Human ProcartaPlex™ Panel 1A. These kits will be used by the Molecular Genetics and Carcinogenesis Section (MGCS) scientific laboratory staff in the Lab of Human Carcinogenesis. These kits are required by our laboratory to perform essential experiments including replicates as a part of analysis of multiple cytokines and chemokines in mouse and human plasma and lung tissues. We need 2 kits each for analysis of up to 80 samples. (Each item includes 96 tests per kit. 16 tests for standard curve. We will need to do duplicates for each samples therefore the rest 80 tests we could do up to 40 samples for each kit). The laboratory currently has performed this type of analysis previously and thus it is important to utilize identical kits as before and as these assays will be run on NIH core equipment, they must be compatible.

The National Cancer Institute plans to purchase these kits from Life Technologies. This is not a request for competitive quotation. However, if any interested party believes it can meet the attached requirements, it may submit a statement of capabilities. The capability statement must be in writing and must contain information and material in sufficient detail to allow NCI to determine if the party can fully meet this requirement. The capability statement must be received in the contracting office by 11:30 AM on January 28, 2022 ET. A determination by the Government not to compete this requirement based upon responses to this notice is solely within the discretion of the Government. Information received will be considered solely for the purpose of determining whether to conduct a competitive procurement.

Sole Source Justification:

Life Technologies is the only company that sells these kits and is fully compatible with the Luminex xMAP technology available via the NIH/NCI protein core labs. Also, previous experimentation has been performed utilizing these kits and thus to maintain the NIH standard for scientific reproducibility and rigor, the use of the identical kits is crucial. The samples being analyzed are precious, irreplaceable and in limited quantity. Therefore performing the analysis using the optimized conditions, which include these kits, empirically determined from previous experimentation is the most effective way to proceed with the new analysis.

1.0 TITLE

Purchase of human and mouse ProcartaPlex Panel Cytokine kits (ThermoFisher)

2.0 BACKGROUND

The Laboratory of Human Carcinogenesis (LHC) of the NCI, NIH has ongoing experimental plans that require the purchase of both ThermoFisher [Cytokine & Chemokine Convenience 36-Plex Mouse ProcartaPlex™ Panel 1A](#) and [Cytokine & Chemokine Convenience 34-Plex Human ProcartaPlex™ Panel 1A](#). These kits will be used by the Molecular Genetics and Carcinogenesis Section (MGCS) scientific laboratory staff in the Lab of Human Carcinogenesis. These kits are required by our laboratory to perform essential experiments including replicates as a part of analysis of multiple cytokines and chemokines in mouse and human plasma and lung tissues. We need 2 kits each for analysis of up to 80 samples. (Each item includes 96 tests per kit. 16 tests for standard curve. We will need to do duplicates for each samples therefore the rest 80 tests we could do up to 40 samples for each kit). 3.0 TYPE OF ORDER

This is a sole source order with NIH specific pricing from ThermoFisher Scientific.

4.0 SPECIAL ORDER REQUIREMENTS

4.1 PRODUCT FEATURES/SALIENT CHARACTERISTICS

The Mouse Cytokine/Chemokine Convenience 36-Plex ProcartaPlex Panel 1 and Cytokine & Chemokine Convenience 34-Plex Human ProcartaPlex Panel 1A enables the study of immune function by analyzing 36 protein targets in a single well using Luminex xMAP technology. The ProcartaPlex immunoassays are based on the principles of a sandwich ELISA, using two highly specific antibodies binding to different epitopes of one protein to quantitate all protein targets simultaneously using a Luminex instrument. ProcartaPlex multiplex assays require as little as 25 µL of plasma or serum, or 50 µL of cell culture supernatant, and just four hours to obtain analyzed results.

Features include:

- Reproducible, reliable results—validated as a panel to the highest industry standard, including protein target combinability and cross-reactivity testing

(d) *Inspection/Acceptance.* The Contractor shall tender for acceptance only those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. The Government must exercise its postacceptance rights-

(1) Within a reasonable period of time after the defect was discovered or should have been discovered; and

(2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(e) *Excusable delays.* The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence, such as acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(f) *Termination for the Government's convenience.* The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges that the Contractor can demonstrate to the satisfaction of the Government, using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred that reasonably could have been avoided.

(g) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(h) *Warranty.* The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.
