Subject: NCI Bid Board Posting – to provide maintenance/service agreement for four (4) GE Healthcare Life Sciences (aka Cytiva) Protein Purification systems

The Laboratory of Metabolism (LM), founded in 1996, consists of five principal investigators. Members of the LM are international leaders in drug and carcinogen metabolism, mechanisms of chemical carcinogenesis, nuclear receptors, mammalian developmental biology, chromosomal proteins and chromatin biology, studies on B-ZIP transcription factors, and the control of mitosis by protein kinases, and cell cycle regulation. We have distinct but overlapping research interests focusing on areas that include 1) drug and carcinogen metabolism, 2) chemical carcinogenesis and chemoprevention, 3) mechanisms of carcinogenesis, 4) signal transduction and cell cycle control, 5) developmental biology, 6) epigenetic gene regulation and chromatin biology.

The LM, Chemistry Section (CS), studies the role of polo-like kinases (PLK) in cell proliferation. The protein purification systems are used to produce highly purified kinases needed for ultimate crystallization. It is critical that the equipment mentioned in this contract is calibrated accurately and maintained in good working condition according to the manufacturer's specifications. Any deviation from the specifications could ruin countless hours of work, waste crucial resources and distort further studies.

The National Cancer Institute plans to purchase this service agreement for four GE Healthcare Life Science Protein Purification system with Cytiva-Global Life Science Solutions (formally GE Healthcare Life Sciences to perform this work. This is not a request for competitive quotation. However, if any interested party believes it can meet the attached requirements, it may submit a statement of capabilities. The capability statement must be in writing and must contain information and material in sufficient detail to allow NCI to determine is the party can fully meet this requirement. The capability statement must be received in the contracting office by 11:30 AM on December 17th ET. A determination by the Government not to compete this requirement based upon responses to this notice is solely within the discretion of the Government. Information received will be considered solely for the purpose of determining whether to conduct a competitive procurement.

Sole Source Justification:

Cytiva-Global Life Sciences Solutions (formally GE Healthcare Life Sciences) is the only manufacturer which has all the required documents and schematics necessary to service GE Healthcare Life Sciences protein purification products so that they are maintained at design specifications. The specifications necessary to manufacture spare parts are proprietary to GE Healthcare Sciences. They do not have agreements to supply spare parts with any distributors or service providers, and do not provide Service Engineer level training to anyone except GE Healthcare Life Sciences engineers. Additionally, maintenance/service visits, including full system diagnostics, require GE Exclusive software.

## STATEMENT OF WORK

1. **SCOPE:** Contractor to provide all labor, material and equipment to provide preventive maintenance/repair service for government-owned Cytiva (formerly GE Healthcare Biosystems) FPLC systems listed here: AKTA Pure 25 L1 FPLC system (Serial # 29018225-1962862), AKTA Pure 25 L1 FPLC system (Serial # 29018225-2226473), AKTA Purifier UPC100 FPLC system (Serial # 28406271-1389954) and AKTA Pure 25 M FPLC system (Serial # 29018226-2650884). All maintenance/repair services shall be performed in accordance with the manufacturer's standard commercial maintenance practices.

2. **PREVENTIVE MAINTENANCE:** Contractor shall perform one (1) preventive maintenance inspections (PMI) per system during the contract period. Service shall be performed by technically qualified OEM factory trained personnel. Service shall consist of a thorough cleaning, calibration, adjusting, inspection, lubrication and testing of all equipment in accordance with the manufacturer's latest established service procedures. All equipment shall be operationally tested through at least one (1) complete operating cycle at the end of the preventive maintenance inspection assure optimum and efficient performance. The service engineer will document each PM visit and provide a service report on completion of the visit.

3. **REPAIR SERVICE:** Emergency repair services shall be provided on an unlimited basis during the term of this contract at no additional cost to the government. Emergency service shall be provided during normal working hours, Monday thru Friday excluding Federal Holidays. Upon receipt of notice that any part of the equipment is not functioning properly the Contractor shall furnish a qualified factory-trained OEM service representative to inspect the equipment and perform all repairs and adjustments necessary to restore the equipment to normal and efficient operating condition. Emergency service calls shall not replace the necessity for scheduled PMIs. All parts and labor costs are covered under this contract.

#### 4. REPLACEMENT PARTS:

The contractor shall furnish all required replacement parts at no additional cost to the Government, with the exception of consumable parts to include batteries. Parts shall be new OEM replacement parts specified to original equipment specifications. Contract does not cover normal consumable products (with the exception of lamps).

#### 5. SOFTWARE UPDATES/SERVICE

The contractor shall provide Software Service in accordance with the manufacturer's latest established service procedures, to include telephone access to technical support for use of program software and trouble shooting of the operating systems, at no additional cost to the Government. The contractor shall receive advance approval for the installation of all software updates and revisions from the Government. Defective software shall be replaced at no additional cost to the government. All software updates and revisions are provided at no additional cost to the government.

## 6. SERVICE EXCLUSIONS

The contractor shall not be responsible for any repairs necessitated by abuse, neglect, vandalism, Acts of God, fire or water. These repairs shall be the subject of a separate purchase order and shall not be performed under this contract.

(d) *Inspection/Acceptance.* The Contractor shall tender for acceptance only those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. The Government must exercise its postacceptance rights-

(1) Within a reasonable period of time after the defect was discovered or should have been discovered; and

(2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(e) *Excusable delays.* The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence, such as acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges that the Contractor can demonstrate to the satisfaction of the Government, using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred that reasonably could have been avoided.

(g) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(h) *Warranty.* The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.
