Subject: NCI Bid Board Posting – Maintenance of levels of LN2 in Cryogenic Storage Units

The National Cancer Institute (NCI), The Laboratory of Pathology (LP) at the National Cancer Institute (NCI) is an integral component of the research and clinical community at the National Institutes of Health (NIH). Our goal is to be a globally recognized center of excellence in disease research, clinical diagnostics, and pathology education. The mission of the Laboratory of Pathology is to achieve the highest level of quality in research, diagnostics, and education.

The primary objective is for routine deliveries of Liquid Nitrogen required to maintain irreplaceable patient and research specimens stored in Cryogenic Storage Units within the NIH, NCI, CCR, LP. These deliveries shall be uninterrupted to preserve the integrity of the specimens stored within each Cryogenic Freezer. In the event of an emergency service request, contractor shall respond 24-hour, 365 days a year for loss of liquid nitrogen in storage freezers or malfunctioning instrumentation. The lab strives to continue to serve the NIH research team to the benefit of the Government.

The National Cancer Institute Plans to purchase Liquid Nitrogen Cylinders from Roberts Oxygen, Inc. This is not a request for competitive quotation. However, if any interested party believes it can meet the attached requirements, it may submit a statement of capabilities. The capability statement must be in writing and must contain information and material in sufficient detail to allow NCI to determine if the party can fully meet this requirement. The capability statement must be received in the contracting office by 11:30 AM on May 15, 2022. ET. A determination by the Government not to compete this requirement based upon responses to this notice is solely within the discretion of the Government. Information received will be considered solely for the purpose of determining whether to conduct a competitive procurement.

Sole Source Justification:

The Laboratory of Pathology has the responsibility to maintain (levels of liquid nitrogen) in all Cryogenic Freezers for the purpose of maintaining irreplaceable specimen samples for patient Diagnosis and Research. The Liquid Nitrogen Cylinders are maintained by the Contractor and are rented by the Laboratory of Pathology to provide routine deliveries to specified locations in Building 10, Floors 2N Corridor, B1 Corridor, Rooms 2B33 and 2C533 (Operating Rooms). All Cryogenic Freezers are monitored by Contractor using a check-stop daily procedure to ensure all equipment is functioning properly and levels of Liquid Nitrogen are sufficient. Contractor is on-site daily, a key factor in maintaining the support required for the equipment and to provide uninterrupted support to our Researchers. Other vendors contacted are capable of delivering only Liquid Nitrogen they either deliver in bulk or do not deliver inside on a daily basis to 240 liter or 160 liter storage containers with a Check-Stop daily check on each Freezer, this does not fit our specific need. Therefore, the proposed contractor will be the only one that can satisfy our proposed requirement.

1.0 TITLE

Maintenance of levels of LN2 in Cryogenic Storage Units, Laboratory of Pathology, CCR, NCI

2.0 BACKGROUND

This purchase request is for routine deliveries of Liquid Nitrogen required to maintain irreplaceable patient and research specimens stored in Cryogenic Storage Units within the NIH, NCI, CCR, LP. These deliveries shall be uninterrupted to preserve the integrity of the specimens stored within each Cryogenic Freezer. In the event of an emergency service request, contractor shall respond 24-hour, 365 days a year for loss of liquid nitrogen in storage freezers or malfunctioning instrumentation. We strive to continue to serve the NIH research team to the benefit of the Government.

2.1 OBJECTIVE

The Laboratory of Pathology has the responsibility to maintain (levels of liquid nitrogen) in all Cryogenic Freezers for the purpose of maintaining irreplaceable specimen samples for patient Diagnosis and Research. The Liquid Nitrogen Cylinders are maintained by the Contractor and are rented by the Laboratory of Pathology to provide routine deliveries to specified rooms located in building 10, floors B1 and 2. All Cryogenetic Freezers are monitored by Contractor using a check-stop daily procedure to insure all equipment is functioning properly and levels of Liquid Nitrogen are sufficient. Contractor is on-site daily, a key factor in maintaining the support required for the equipment and to provide uninterrupted support to our Researchers.

3.0 SCOPE

Contractor shall perform check-stops scheduled daily (Monday thru Saturday) for LN2 maintenance inspections during the contract period. Service shall consist of delivery and refilling of all Liquid Nitrogen Source Tanks by contractor in accordance with the manufacturer's latest established service procedures. All equipment shall be operationally tested through at least one (1) complete operating cycle at the end of the preventive maintenance inspection to assure optimum and efficient performance.

4.0 CONTRACT REQUIREMENTS/ AND PERSONNEL QUALIFICATIONS

Contractor shall perform check-stops scheduled daily (Monday thru Saturday) for LN2 maintenance inspections during the contract period. Service shall be performed by technically qualified factory trained personnel. Service shall consist of delivery, installation, calibration, adjusting, inspection, and

refilling of all Liquid Nitrogen Source Tanks by contractor in accordance with the manufacturer's latest established service procedures.

8.0 REPORT(S)/DELIVERABLES AND DELIVERY SCHEDULE

Delivery of LN2 shall be provided on an unlimited basis during the term of this contract at no additional cost to the government. Liquid Nitrogen and cylinder maintenance shall be provided for Government-owned Cryogenic Freezers, located in bldg. 10, floors B1 & 2N, 2B. Emergency service shall be provided during normal working hours, Monday thru Friday excluding Federal Holidays.

9.0 PAYMENT

Payment shall be made (arrears). Payment authorization requires submission and approval of invoices to the COR and NIH OFM, in accordance with the attached payment provisions listed below:

STATEMENT OF WORK (SOW)

I INVOICE REQUIREMENTS

- A. An invoice is the Contractor's bill or written request for payment under the contract for supplies delivered or services performed. II. INVOICE PAYMENT

Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges that the Contractor can demonstrate to the satisfaction of the Government, using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred that reasonably could have been avoided.

I Invoice Requirements

- A. An invoice is the Contractor's bill or written request for payment under the contract for supplies delivered or services performed. A proper invoice is an "Original" which must include the items listed in subdivisions 1 through 12, below, in addition to the requirements of FAR 32.9. If the invoice does not comply with these requirements, the Contractor will be notified of the defect within 7 days after the date the designated billing office received the invoice (3 days for meat, meat food products, or fish, and 5 days for perishable agricultural commodities, dairy products, edible fats or oils) with a statement of the reasons why it is not a proper invoice. (See exceptions under II., below.) Untimely notification will be taken into account in the computation of any interest penalty owed the Contractor.

In order to facilitate the prompt payment of invoices, it is recommended that the vendor submit a photocopy of the invoice to the "Consignee" designated for the acquisition in blocks 6A – 6E of the face page of the Order/Award document.

II. Invoice Payment

- A. Except as indicated in paragraph B., below, the due date for making invoice payments by the designated payment office shall be the later of the following two events:
1. The 30th day after the designated billing office has received a proper invoice.
 2. The 30th day after Government acceptance of supplies delivered or services performed.

- B. Determination of interest and penalties due will be made in accordance with the provisions of the Prompt Payment Act, as amended, the Contract Disputes Act, and regulations issued by the Office of Management and Budget.

IV. PROVIDING ACCELERATED PAYMENT TO SMALL BUSINESS SUBCONTRACTORS, FAR 52.232-40 (December 2013)

- a.
