Subject: NCI Bid Board Posting – Fetal Bovine Serum-Heat Inactivated LOT#22H022 for LTIB.

The Lab of Tumor Immunology & Biology (LTIB) functions as an integrated translational research program, which designs and develops novel immunotherapeutic and immunologic strategies for cancer treatment and prevention. Fetal Bovine Serum (FBS) is required for maintaining cell populations used for LTIB immunotherapy in vitro experiments and must remain uniform across experiments to ensure reproducibility.

The primary objective of this acquisition is to obtain 150 Bottles of Human AB Serum, Heat Inactivated LOT#22H022 from Omega Scientific.

This is not a request for competitive quotation. However, if any interested party believes it can meet the attached requirements, it may submit a statement of capabilities. The capability statement must be in writing and must contain information and material in sufficient detail to allow NCI to determine is the party can fully meet this requirement. The capability statement must be received in the contracting office by 11:30 AM on July 11, 2022 ET. A determination by the Government not to compete this requirement based upon responses to this notice is solely within the discretion of the Government. Information received will be considered solely for the purpose of determining whether to conduct a competitive procurement.

**Sole Source Justification:**

The laboratory would like to purchase a large lot 150 bottles of a remaining lot 22H022 that has been tested and used previously in the LTIB. These results have been exceptional, and this lot of sera will enable the probability of introducing new variables in the experimental results. Changing the variables now would result in incorrect interpretation of the immune assays in progress. We want to keep the continuity and reproducibility of ongoing experiments. The below chart lists the companies tested and the company/lot of serum that performed at the highest level of T-cell proliferation is highlighted.

### 2.0 BACKGROUND

The Center for Immuno-Oncology (CIO) functions as an integrated translational research program, which designs and develops novel immunotherapeutic and immunologic strategies for cancer treatment and prevention.

The laboratory has previously selected a source of Human Ab Serum for cell growth media to support immune assays and tissue culture requirements for the use by the entire CIO-Translational group. The company will provide Human Ab Serum generated from the same lot (#22H022) (150 bottles) previously tested and has been continuously in use by all groups within the Laboratory. It is now necessary for the Laboratory to purchase additional bottles of Human Ab Serum from this same lot number that have been on hold for us at the company, so that we can continue all the ongoing experiments supporting the immune assays in an optimal way. Changing the variables at this time would result in incorrect interpretation of the immune assays in progress and cause considerable delays of planned projects.

The Contractor shall not be paid for any work performed or costs incurred that reasonably could have been avoided.

(g) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(h) *Warranty.* The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.
