Subject: NCI Bid Board Posting – to purchase gentleMACS Octo Dissociator with Heaters

The Laboratory of Human Carcinogenesis has a multifaceted research program integrating basic, translational, clinical, and population research, with a major focus on common and lethal human cancers that include tumors of the breast, colon, esophagus, liver, lung, pancreas and prostate. Our studies utilize a Precision Medicine Strategy. Our main objectives are to conduct investigations that assess: (1) Mechanisms of carcinogenesis including the cellular functions of cancer driving genes; (2) experimental approaches in biological systems for the extrapolation of carcinogenesis data and mechanisms from in vitro models and experimental animals to humans; (3) molecular integrative epidemiology of human cancer risk; and (4) cancer biomarkers of diagnosis, prognosis, and therapeutic outcome.

The Laboratory of Human Carcinogenesis (LHC) of the NCI, NIH has a requirement to purchase a new gentleMACS Octo Dissociator with Heaters. This dissociator will be used by the entire scientific laboratory staff in LHC. This instrument is required by the laboratory to perform effective dissociation of tissues and/or tumor materials. The laboratory currently has an instrument that is very old, requires separate peripheral equipment for completion of dissociation process, and lacks significantly updated features that would greatly improve the effectiveness of the dissociation process. There is no current manufacturer warranty on this unit and there is concern that this current unit cannot withstand the frequency with which we use the machine. And the peripheral equipment that is needed is already non-operational. Therefore, there is a need to replace this unit with a much more reliable piece of equipment. Miltenyi Biotec is the sole source company that manufactures the updated dissociator model needed to replace the current Miltenyi Biotec model. This newer model has been demonstrated in the laboratory and shown to be a significant enhancement to the dissociation protocols used throughout LHC.

The National Cancer Institute plans to purchase the gentleMACS™ Octo Dissociator with Heaters from Miltenyi Biotec. This is not a request for competitive quotation. However, if any interested party believes it can meet the attached requirements, it may submit a statement of capabilities. The capability statement must be in writing and must contain information and material in sufficient detail to allow NCI to determine if the party can fully meet this requirement. The capability statement must be received in the contracting office by 11:30 AM on August 9, 2022, ET. A determination by the Government not to compete this requirement based upon responses to this notice is solely within the discretion of the Government. Information received will be considered solely for the purpose of determining whether to conduct a competitive procurement.

Sole Source Justification:

The gentleMACS Octo Dissociator with Heaters is proprietary to Miltenyi Biotec. The products are offered exclusively by Miltenyi Biotec and not available from other vendors.

### **1.0 TITLE**

Purchase of Miltenyi Biotec gentleMACS Octo Dissociator with Heaters

### **2.0 BACKGROUND**

The Laboratory of Human Carcinogenesis (LHC) of the NCI, NIH has a requirement to purchase a new gentleMACS Octo Dissociator with Heaters. This dissociator will be used by the entire scientific laboratory staff in the Laboratory of Human Carcinogenesis. This instrument is required by our laboratory to perform effective dissociation of tissues and/or tumor materials. The laboratory currently has an instrument that is very old, requires separate peripheral equipment for completion of dissociation process, and lacks significantly updated features that would greatly improve the effectiveness of the dissociation process. There is no current manufacturer warranty on this unit and there is concern that this current unit cannot withstand the frequency with which we use the machine. And the peripheral equipment that is needed is already non-operational.

Therefore, there is a need to replace this unit with a much more reliable piece of equipment. Miltenyi Biotec is the sole source company that manufactures the updated dissociator model needed to replace the current Miltenyi Biotec model. The upgraded features will allow additional experimental efficiency and effectiveness to be completed for our staff.

The new gentleMACS Octo Dissociator with Heaters are the only devices that can dissociate/homogenize a variety of tissue samples utilizing gentleMACS tubes. This updated model allows for the dissociation of up to eight samples, greatly expanding the capabilities in the lab.
