The Neuro-Oncology Branch (NOB) is a trans-institutional initiative that launched in 2000. NOB is sponsored by both the National Cancer Institute (NCI) and the National Institute of Neurological Disorders and Stroke (NINDS). Our mission is to develop novel diagnostic and therapeutic agents for patients with primary central nervous system tumors. The branch's strategic direction is founded on the belief that the continued application of the traditional and largely empiric approach to cancer drug development that has dominated oncology for three decades will likely result in only small, incremental progress in the treatment of patients with malignant gliomas.

The primary objective is to purchase a commercially available Brand Name Peak Scientific Genius XE35 120V Nitrogen Generator (with 12 month Preventative Maintenance Warranty). To include all shipping charges.

The National Cancer Institute plans to purchase Multi-Mode Plate Reader. This is not request for competitive quotation. However, if any interested party believes it can meet the attached requirements, it may submit a statement of capabilities. The capability statement must be in writing and must contain information and material in sufficient detail to allow NCI to determine if the party can fully meet this requirement. The capability statement must be received in the contracting office by 11:30 AM on July 30, 2022 ET. A determination by the Government not to compete this requirement based upon responses to this notice is solely within the discretion of the Government. Information received will be considered solely for the purpose of determining whether to conduct a competitive procurement.

Sole Source Justification: is to purchase a commercially available Brand Name Peak Scientific Genius XE35 120V Nitrogen Generator (or equivalent) for system pressurization and vehicle gas flow to support LC/QTOF mass spectrometer system for use by the Neuro-Oncology Branch within the Center for Cancer Research at the NCI. Purchase of this instrument is indispensable to the mission of NIH. The technology is essential for advancing research of brain cancer at CCR and NCI.

1.0 TITLE

Procurement of a Brand Name or Equal Peak Scientific Genius XE35 120V Nitrogen Generator (with Preventative Maintenance Warranty)

2.0 BACKGROUND

The National Cancer Institute (NCI), Center for Cancer Research (CCR), Neuro-Oncology Branch (NOB) requires one (1) new, commercially available, nitrogen generator benchtop electrochemiluminescence immunoassay system capable of detection and analysis. The NCI/CCR/NOB performs translational research on brain tumors, using biological, biochemical, pathological, and immunological methods to identify underlying mechanisms and develop novel therapeutics for patients with brain tumors. In the on-going neuro-oncology research projects, we have been using Agilent Liquid Chromatography - Mass Spectrometer system (LC/QTOF System, NIH #02049782 and #02049773), for NOB pre-clinical translational research on pharmacokinetic and metabolic analyses. It is critical to have stable nitrogen gas supply to support the instrument air-table. Because of relocation of this LC/QTOF System, there is no such pipeline nitrogen gas source in the new location at Building 37, a nitrogen generator for LCMS is therefore necessary to order. This work will benefit the government by advancing the understanding metabolic response within, identifying biomarkers for and the treatment of brain cancer.

3.0 OBJECTIVE

The purpose of this requirement is to purchase a commercially available Brand Name Peak Scientific Genius XE35 120V Nitrogen Generator for system pressurization and vehicle gas flow to support LC/QTOF mass spectrometer system for use by the Neuro-Oncology Branch within the Center for Cancer Research at the NCI. Purchase of this instrument is indispensable to the mission of NIH. The technology is essential for advancing research of brain cancer at CCR and NCI.

4.0 TYPE OF ORDER

This will be issued as a Firm Fixed-Price Purchase Order.

5.3 DELIVERY GUIDANCE

Due to the current COVID-19 pandemic, the vendor must pay close attention to the following delivery instructions. Please be aware that due to the fluidity of the existing pandemic, instructions may be updated as needed after award.

The Contractors shall communicate and follow instructions from the Technical Point of Contact (TPOC) to coordinate delivery, installation and training.

STATEMENT OF NEED (SON)

The Contractor shall store or retain all supplies furnished under this order until notified by the NCI Contracting Officer or Technical Point of Contact (TPOC) of a delivery date. The Contractor shall deliver supplies no later than 30-days after notification.

The Contractor shall not sell supplies furnished under this order to another company or party if the NCI is unable to accept delivery due to conditions related to COVID-19.

Training and installation as required by the Statement of Need may be delayed due to conditions related to COVID-19. If services provided under this order are delayed, the Contractor shall provide all services at different times and dates at no additional cost.

The Contractor shall direct all courier and delivery services – including those not operated by the Contractor (e.g. FedEx, USPS, UPS) – to follow the instructions in this section.

All companies delivering to the NIH main campus must comply with Commercial Vehicle Inspection Facility (CVIF) access procedures. Upon arrival, the CVIF will provide a list of buildings and loading docks to delivery personnel.

(d) *Inspection/Acceptance.* The Contractor shall tender for acceptance only those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. The Government must exercise its postacceptance rights-

(1) Within a reasonable period of time after the defect was discovered or should have been discovered; and

(2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(e) *Excusable delays.* The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence, such as acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(f) *Termination for the Government's convenience.* The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges that the Contractor can demonstrate to the satisfaction of the Government, using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred that reasonably could have been avoided.

(g) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(h) *Warranty.* The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.
