The Laboratory of Genitourinary Cancer Pathogenesis (LGCP) Microscopy Core Facility of the DHHS/NIH/NCI/CCR has a need for an HP Z6 Workstation to upgrade the capabilities of (1) Carl Zeiss AxioScan.Z1 microscope in the Core. The LGCP Microscopy Core Facility has the responsibility to maintain the equipment in the Core, and keep it fully functional and at a state-of-the-art level to support the work of LGCP investigators, as well as scientists from other laboratories in the NCI. The LGCP Microscopy Core Facility has a Carl Zeiss AxioScan.Z1 slide microscope that was purchased in 2014. The Axioscan is in use 24 hours a day, seven days a week with a 22-week waiting list for scheduling time on the instrument. Over the last 7 years, researchers from 56 different labs have used the Axioscan in the Core. No other CCR Core Facility has slide scanning capabilities. Any instrument downtime has a serious impact on the work of multiple NCI and CCR laboratories.

The PC workstation that controls the microscope runs on Windows 7. Unfortunately, the newest version of Carl Zeiss Zen software supported on Win7 is version 2.6, which is no longer actively maintained by Zeiss. Any imaging or software issues on the AxioScan iarea major potential system breakpoint unless we upgrade to the newest version 3.5 of Zen software which requires a Windows 10 machine.

The acquisition of this new workstation will allow the LGCP Microscopy Core Facility to better support the current needs of researchers in the LGCP, as well as in the NCI/CCR.

The National Cancer Institute plans to purchase the HP Z6 Workstation from Carl Zeiss Microscopy. This is not a request for a competitive quotation. However, if any interested party believes it can meet the attached requirements, it may submit a statement of capabilities. The capability statement must be in writing and must contain information and material in sufficient detail to allow NCI to determine if the party can fully meet this requirement. The capability statement must be received in the contracting office by 11:30 AM on August 9, 2022, ET. A determination by the Government not to compete this requirement based upon responses to this notice is solely within the discretion of the Government. Information received will be considered solely for the purpose of determining whether to conduct a competitive procurement.

Sole Source Justification:

Carl Zeiss is the only vendor able to provide a workstation with the required hardware and software needed to run the Carl Zeiss AxioScan.Z1 slide scanning microscope in the LGCP Microscopy Core Facility. While other vendors could supply some of the workstation hardware, the workstation would not have the correct Windows Windows 10 LSTC 2019 with SysConf AxioScan image installed with licensed Carl Zeiss Zen 3.5 software with the correct image analysis and processing modules. Carl Zeiss is the only source for the needed workstation.

5.0 PAYMENT

In order to facilitate the prompt payment of invoices, it is recommended that the vendor submit a photocopy of the invoice to the "Consignee" designated for the acquisition in blocks 6A – 6E of the face page of the Order/Award document.

II. INVOICE PAYMENT

- A. Except as indicated in paragraph B., below, the due date for making invoice payments by the designated payment office shall be the later of the following two events:

(d) *Inspection/Acceptance.* The Contractor shall tender for acceptance only those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. The Government must exercise its postacceptance rights-

(1) Within a reasonable period of time after the defect was discovered or should have been discovered; and

(2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(e) *Excusable delays.* The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence, such as acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(f) *Termination for the Government's convenience.* The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges that the Contractor can demonstrate to the satisfaction of the Government, using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred that reasonably could have been avoided.

(g) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(h) *Warranty.* The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.
