Subject: NCI Bid Board Posting – to procure Next Generation Sequencing Standard RNA-seq

The Laboratory of Human Carcinogenesis (LHC) has a multifaceted research program integrating basic, translational, clinical, and population research, with a major focus on common and lethal human cancers that include tumors of the breast, colon, esophagus, liver, lung, pancreas, and prostate. Our studies utilize a Precision Medicine Strategy. Our main objectives are to conduct investigations that assess: (1) Mechanisms of carcinogenesis, including the cellular functions of cancer-driving genes; (2) experimental approaches in biological systems for the extrapolation of carcinogenesis data and mechanisms from in vitro models and experimental animals to humans; (3) molecular integrative epidemiology of human cancer risk; and (4) cancer biomarkers of diagnosis, prognosis, and therapeutic outcome.

LHC requires library preparation, RNA sequencing using the Illumina platform, standard RNA sequencing analysis, and data delivery of 100 RNA samples derived from human glioblastoma cell lines (GBM) transfected with siRNA targeting the alternative splicing factor SRSF3, or overexpressing the p53 isoform p53 beta.

The National Cancer Institute plans to procure Next Generation Sequencing Standard RNA-seq from Azenta US, Inc. Indianapolis, IN, to perform this work. This is not a request for a competitive quotation. However, if any interested party believes it can meet the attached requirements, it may submit a statement of capabilities. The capability statement must be in writing and must contain information and material in sufficient detail to allow NCI to determine if the party can fully meet this requirement. The capability statement must be received in the contracting office by 11:30 AM on September 5, 2022, ET. A determination by the Government not to compete this requirement based upon responses to this notice is solely within the discretion of the Government. Information received will be considered solely for the purpose of determining whether to conduct a competitive procurement.

Sole Source Justification:

Azenta provides a unique service of RNA library preparation, sequencing in the Illumina platform, analysis, and data. Due to delays in lentiviral vector and siRNA delivery, this vendor's delivery turnaround time is only 6-8 weeks.

## STATEMENT OF WORK

1. SCOPE: Contractor shall perform library preparation, RNA sequencing using the Illumina platform, standard RNA sequencing analysis and data delivery of 100 RNA samples derived from human glioblastoma cell lines (GBM) transfected with siRNA targeting the alternative splicing factor SRSF3, or overexpressing the p53 isoform p53 beta. The samples are expected to be finalized and shipped to the contractor by end of August or early September 2022. The raw and analyzed data will be delivered by the company within 30-35 business days of receiving the samples. The project is expected to take between 6-8 weeks.

2. REQUIREMENTS: The contractor shall...

- A. Tasks – perform library preparation, sequencing of RNA using the Illumina platform standard RNA sequencing analysis and data delivery.
- B. Reports – raw data and differential gene expression data.
- C. Deliverables – we will receive raw RNA sequencing data in fasta files. We will also receive differential gene expression and enriched pathway data.
- D. Schedule – we will ship our RNA samples in late August or mid September 2022. The raw data and differential gene expression and other analyzed files are expected to be delivered within 30-35 business days, thus, by mid/late November 2022.
- E. Period of Performance – data by mid December 2022.
- F. Government Property – the government property we will be using are RNA samples obtained from human glioblastoma cancer cell lines transfected with siRNA targeting SRSF3 or overexpressing the p53 isoform p53 beta.

(d) *Inspection/Acceptance.* The Contractor shall tender for acceptance only those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. The Government must exercise its postacceptance rights-

(1) Within a reasonable period of time after the defect was discovered or should have been discovered; and

(2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(e) *Excusable delays.* The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence, such as acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(f) *Termination for the Government's convenience.* The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges that the Contractor can demonstrate to the satisfaction of the Government, using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred that reasonably could have been avoided.

(g) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(h) *Warranty.* The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.
