Subject: NCI Bid Board Posting – New Maintenance and Upgrade to Huygens software

The research program in the Laboratory of Receptor Biology and Gene Expression concerns the elucidation of mechanisms involved in the regulation of genetic expression in eukaryotic cells, the architecture and organization of the mammalian nucleus, and the identification of genes and regulatory processes involved in modulated states of expression during oncogenesis.

The Optical Microscopy Core (OMC) in Bldg. 41 has a license for the Huygens software package from Scientific Volume Imaging, Inc. (SVI), an extensive suite of image processing and presentation tools. Huygens is a powerful computer program used for image processing, namely deconvolution. Deconvolution microscopy computationally reduces out-of-focus light and therefore increases the resolution for small objects of the size that is at the resolution limit of conventional wide-field microscopy. Users of the Core observe individual molecules, organelles, and cellular structures in multiple channels either by fluorescence immunostaining or by live fluorescent markers such as GFP, mCherry, HaloTag, SNAP tag, and CLIP tag. Recent applications require long-term imaging in 3D in multiple channels by confocal microscopy and super resolution imaging by SIM. OMC aims to study very small objects (arrays of chromosomal loci, individual mRNA molecules). Other examples include studies of chromosomal translocations, vesicle diversity in lymphocytes, and protein distribution along metaphase chromosomes in individual cells. To obtain new information, OMC must increase the image's resolution and signal-to-noise ratio. Specifically, a powerful program such as Huygens to deconvolve large data obtained by 4D imaging. The upgrade options will further expand Huygens's abilities to perform object tracking, single-molecule localization microscopy analysis, and analysis of clusters

The National Cancer Institute plans to purchase new maintenance and upgrade to Huygens software from Scientific Volume Imaging, Inc. in The Netherlands. This is not a request for a competitive quotation. However, if any interested party believes it can meet the attached requirements, it may submit a statement of capabilities. The capability statement must be in writing and must contain information and material in sufficient detail to allow NCI to determine if the party can fully meet this requirement. The capability statement must be received in the contracting office by 11:30 AM on March 17, 2023, ET. A determination by the Government not to compete for this requirement based upon responses to this notice is solely within the discretion of the Government. Information received will be considered solely for the purpose of determining whether to conduct a competitive procurement.

Sole Source Justification:

Huygens Deconvolution software is a proprietary software package available exclusively through Scientific Volume Imaging. OMC requires a modular software package, such as Huygens, that can be expanded to work with new image types. Furthermore, Huygens allows the processing to be performed on a GPU for faster analysis of the computationally demanding deconvolution.

(SVI) which is an extensive suite of tools for image processing and presentation. The major feature of the Huygens software is the deconvolution of microscopy images providing improved resolution. In addition to deconvolution, SVI offers add-ons to the software to facilitate producing high-quality 3D rendering for publication and presentations, as well as Object identification and Object Tracking.

Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges that the Contractor can demonstrate to the satisfaction of the Government, using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred that reasonably could have been avoided.

(g) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(h) *Warranty.* The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.
