Subject: NCI Bid Board Posting – Milli-Q 7000 Water Purification System

The research program in the Laboratory of Receptor Biology and Gene Expression concerns the elucidation of mechanisms involved in the regulation of genetic expression in eukaryotic cells, the architecture and organization of the mammalian nucleus, and the identification of genes and regulatory processes involved in modulated states of expression during oncogenesis. The lab includes six internationally recognized research groups headed by senior investigators Tom Misteli, Yamini Dalal, Shalini Oberdoerffer, Daniel Larson, and Gordon Hager and tenure-track investigator Efsun Arda.

The National Cancer Institute plans to purchase the Milli-Q 7000 Water Purification System from EMD Millipore Corp, Burlington, MA. This is not a request for a competitive quotation. However, if any interested party believes it can meet the attached requirements, it may submit a statement of capabilities. The capability statement must be in writing and must contain information and material in sufficient detail to allow NCI to determine if the party can fully meet this requirement. The capability statement must be received in the contracting office by 11:30 AM on June 14, 2024, ET. A determination by the Government not to compete with this requirement based upon responses to this notice is solely within its discretion. Information received will be considered exclusively to determine whether to conduct a competitive procurement.

Sole Source Justification:

The Milli-Q 7000 Water Purification System from EMD Millipore Corp, provides NCI/CCR labs with consistent standards and uniformity in the experiments.

1.0 TITLE

Purchase of MilliQ IQ7000 Purification System

2.0 BACKGROUND

This is a joint purchase for the co-use of the Millipore IQ7000 water purification system between the labs of Dr. Tom Misteli, Dr. Gordon Hager, Dr. Dan Larson, and Dr. Gianluca Pegoraro, all within the Laboratory of Receptor Biology and Gene Expression (LRBGE).

Our labs, covering diverse research areas such as genetics/genomics, cell biology, biochemistry, cytology, and biophysics, require ultra-pure water for their experiments. To meet this essential need, we are requesting the acquisition of a Millipore IQ7000 water purification system. This system will provide our researchers with consistent access to the high-quality water necessary for their work.

Additionally, other labs within the LRBGE branch use Milli-Q systems, which ensures consistent standards and results across our experiments. By using the same consumables, we can also reduce costs and maintain uniformity in our procedures.

The Contractor shall not be paid for any work performed or costs incurred that reasonably could have been avoided.
