The NCI plans to purchase this service request from GeneScript USA, Inc. Piscataway, NJ to perform this work. This is not a request for a competitive quotation. The capability statement must be received in the contracting office by 11:30 AM on March 15, 2024 ET. Information received will be considered exclusively to determine whether to conduct a competitive procurement.

STATEMENT OF NEED (SON)

1.0 TITLE

Custom Rabbit Monoclonal Antibodies-Human Soluble Tissue Factor

2.0 BACKGROUND

Our research findings revealed a critical function of the protein Tissue Factor, and demonstrated that the soluble Tissue Factor, not the membrane bound full length Tissue Factor, mediates hypercoagulation under pathological conditions. Also, our findings provided potential therapies for treating sepsis or viral infection-caused thrombosis by targeting soluble Tissue Factor. The sTF is a novel diagnosis marker and could be detected in the early stage of thrombosis. Currently there is no commercial antibody that can specifically detect soluble Tissue Factor but not the membrane non-functioning Tissue Factor. By developing this monoclonal antibody specific to the soluble human tissue factor that can detect soluble tissue factor in blood can be a diagnostic marker of early/ongoing thrombosis/clotting.

Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the

notice of termination, plus reasonable charges that the Contractor can demonstrate to the satisfaction of the Government, using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred that reasonably could have been avoided.

(g) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(h) *Warranty.* The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.
