Subject: NCI Bid Board Posting – purchase service contract for Illumina MiSeq Silver Support Plan

Among the defining concepts of the Genetics Branch is one that underlies its basic research focus and others that form the foundation of its clinical and translational research activities. The concept that underlies basic research is that cancer is a genetic disease caused by genetic instability. That instability is a function of all the inherited and acquired effects that mediate plasticity and alterability at the level of DNA. The success of molecular genetics over the past two decades has been identifying genes involved in growth and development pathways and the mechanisms by which the normal regulation and/or products of these genes are altered in cancer. The elucidation of the necessary and sufficient factors that govern genetic instability, the description of the common and disparate themes among different types of instability, and the cataloging of distinct patterns of gene expression in tumors compared to the normal tissues from which they arise are within the purview and distinct perspective of this branch. There is, in addition, a clinical/translational mantle that this branch is called upon to shoulder.

The Genomics core of the Center for Cancer Research at the National Cancer Institute provides multiple genomics services to advance cancer research. Investigating genetic and epigenetic alterations and their effects on the development and biology of cancer represents one of the most important venues of current cancer research. Using Next-Generation Sequencing, the core can provide the necessary support for studying DNA/promoter interactions, gene expression, methylation, single nucleotide polymorphism (SNP), deletions, insertions, and genomic rearrangements.

To perform this work, the National Cancer Institute plans to purchase the service contract for Illumina Inc., MiSeq Silver Support Plan from Illumina Inc., San Diego, CA. This is not a request for a competitive quotation. However, if any interested party believes it can meet the attached requirements, it may submit a statement of capabilities. The capability statement must be in writing and must contain information and material in sufficient detail to allow NCI to determine if the party can fully meet this requirement. The capability statement must be received in the contracting office by 11:30 AM on July 12, 2024, ET. A determination by the Government not to compete this requirement based upon responses to this notice is solely within the discretion of the Government. Information received will be considered solely to determine whether to conduct a competitive procurement. Sole Source Justification:

NCI has conducted research for service providers for the MiSeq Personal Sequencer. No alternate source for service of these instruments was found. Illumina is the sole service provider of this equipment, and the company can meet all NCI's required specifications.

STATEMENT OF WORK

1. <u>SCOPE</u>: Contractor shall provide all labor, material and equipment necessary to maintain and provide preventive maintenance for 1 government-owned Illumina MiSeq Personal Sequencer (SN M01303) for the period of performance 8/1/24 to 7/31/2025. All maintenance service shall be performed on-site in accordance with the manufacturer's standard commercial maintenance practices.

2. <u>PREVENTIVE MAINTENANCE:</u> Contractor shall perform one (1) preventive maintenance inspections (PMI) during the contract period. Technically qualified factory-trained personnel shall perform Service. The contract will cover service calls, travel time, labor, and any necessary approved parts.

3. <u>EMERGENCY SERVICE</u>: Unlimited emergency repair service visits shall be provided during the term of this contract to the government. Emergency service shall be provided during normal working hours, Monday through Friday excluding Federal Holidays. Upon receipt of notice that any part of the equipment is not functioning properly the Contractor shall within seventy-two (72) hours furnish a qualified factory-trained service representative to inspect the equipment and perform all repairs and adjustments necessary to restore the equipment to normal and efficient operating condition. Emergency service calls shall not replace the necessity for scheduled PMIs.

The contractor shall provide unlimited technical support through email and a hot-line number for telephonic trouble-shooting for the instrument, applications and bioinformatics during normal working hours, except Federal holidays.

4. <u>REPLACEMENT PARTS</u>: The contractor shall furnish all required replacement parts at no additional cost to the Government, except for consumables. Parts shall be new or re-manufactured to original equipment specifications.

5. <u>SOFTWARE UPDATES/SERVICE:</u> Critical and non-critical updates will be provided.

6. <u>SERVICE EXCLUSIONS</u>: The contractor shall not be responsible for any repairs necessitated by abuse, neglect, vandalism, Acts of God, fire or water. These repairs shall be the subject of a separate purchase order and shall not be performed under this contract.

7. <u>PERIOD OF PERFORMANCE</u>: Period of Performance shall be for twelve (12) months from 8/1/24 to 7/31/2025.

STATEMENT OF WORK

8. <u>PERSONNEL QUALIFICATIONS</u>: Personnel shall have a minimum of three (3) years factory training and experience in the servicing of the instrument as covered by this contract. All primary service personnel shall have at least one backup support person with at least the same level of expertise on the equipment covered by this contract.

9. <u>PLACE OF PERFORMANCE:</u> Service shall be performed at the following location:

(d) *Inspection/Acceptance*. The Contractor shall tender for acceptance only those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. The Government must exercise its post acceptance rights-

(1) Within a reasonable period of time after the defect was discovered or should have been discovered; and

(2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(e) *Excusable delays*. The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence, such as acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(f) *Termination for the Government's convenience*. The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the

notice of termination, plus reasonable charges that the Contractor can demonstrate to the satisfaction of the Government, using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred that reasonably could have been avoided.

(g) *Termination for cause*. The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(h) *Warranty*. The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.
