Subject: NCI Bid Board Posting – procure service contract for Mosquito Reliance Complete

The research program in the Laboratory of Receptor Biology and Gene Expression (LRBGE) concerns the elucidation of mechanisms involved in the regulation of genetic expression in eukaryotic cells, the architecture and organization of the mammalian nucleus, and the identification of genes and regulatory processes involved in modulated states of expression during oncogenesis.

LRBGE requests to purchase a one-year equipment service agreement for the maintenance of a Mosquito MHV062. The agreement will include preventive maintenance, on-site repair and refurbishment, telephone and remote troubleshooting/access support, and instrument software bug fixes and updates.

The Mosquito MHV062 provides NCI and NIH researchers with essential high-throughput molecular biology technologies to interrogate chromatin and gene expression profiles of single cells isolated from patients. The Mosquito MHV062 is capable of automatically handling (e.g., aspirating, transferring, and mixing nano and microliter amounts of chemicals or reagents in liquid form) thousands of cells at once with accurate pipetting capabilities of nanoliter scale liquids in under 5 minutes.

To perform this work, the NCI plans to purchase this service request from the original manufacturer, SPT Lab Tech Limited. This is not a request for a competitive quotation. However, if any interested party believes it can meet the attached requirements, it may submit a statement of capabilities. The capability statement must be in writing and must contain information and material in sufficient detail to allow NCI to determine if the party can fully meet this requirement. The capability statement must be received in the contracting office by 11:30 AM on November 15, 2024, ET. A determination by the Government not to compete this requirement based upon responses to this notice is solely within the discretion of the Government. Information received will be considered exclusively to determine whether to conduct a competitive procurement.

Sole Source Justification:

Due to the proprietary nature of the instrumentation, only SPT LabTech Limited trained technicians are authorized to repair and maintain Mosquito MHV062.

STATEMENT OF WORK

1.0 SCOPE

The Contractor shall provide all labor, material and equipment necessary to maintain and provide preventive maintenance for one (1) government-owned equipment: Mosquito MHV062 (Serial number# MHV062 and NIH decal # 02116084).

The repair services for the Mosquito MHV062 shall be performed on-site and replacement services in accordance with the manufacturer's standard commercial maintenance practices.

2.0 EMERGENCY SERVICE

On-site, all repair and/or replace service shall be performed and provided during the term of this contract at no additional cost to the government. Emergency service shall be provided during normal working hours, Monday through Friday, excluding Federal Holidays. Upon receipt of notice that any part of the equipment is not functioning properly the Contractor shall acknowledge receipt of a service request within four (4) hours business working time.

For Mosquito MHV062, a service call will be opened for the equipment and an engineer will come onsite within two (2) working days to perform the repair if the service request cannot be resolved over the telephone, by e-mail or by remote connect support sessions.

Labor, parts, shipping and travel will be included for all above-mentioned services.

3.0 REPLACEMENT PARTS

The Contractor shall furnish all required replacement parts at no additional cost to the originator of this contract (NIH/NCI/CCR/LRBGE). Parts shall be new to original equipment specifications.

4.0 MAINTENANCE SERVICE

The contractor must provide no less than one (1) preventative maintenance visit per contract year for the Mosquito MHV062 on this contract. Service shall consist of a thorough cleaning, calibration, adjusting, inspection, and testing of the equipment in accordance with the manufacturer's latest established service procedures. All equipment shall be operationally tested through at least one (1) complete operating cycle at the end of the preventative maintenance inspection to assure optimum and efficient performance. All maintenance services shall be performed in accordance with the manufacturer's standard commercial maintenance practices.

5.0 SOFTWARE UPDATES/SERVICE

The Contractor shall provide Software Service and updates in accordance with the manufacturer's latest established service procedures, to include telephone access to technical support for use of program software and trouble shooting of the operating systems, at no additional cost to the Government. The contractor shall receive advance

approval for the installation of all software updates and revisions from the Government. Defective software shall be replaced at no additional cost to the government.

The Contractor shall provide unlimited technical support either via remote login session (Webex) to the scientific equipment workstation and/or via email, and/or via phone to trouble-shoot the instrument and its applications during normal working hours (EST), Monday through Friday, except Federal holidays.

6.0 SERVICE EXCLUSIONS

The Contractor shall not be responsible for any repairs necessitated by abuse, neglect, vandalism, Acts of God, fire or water. These repairs shall be the subject of a separate purchase order and shall not be performed under this contract.

7.0 PERSONNEL QUALIFICATIONS

Personnel shall have a minimum of 3 years factory training and experience in the servicing of Mosquito MHV062 as covered by this contract. All primary service personnel shall have at least one backup support with at least the same level of expertise on the equipment covered by this contract.

8.0 PERIOD OF PERFORMANCE

The base period of performance shall be for one year from 11/15/2024 to 11/14/2025

The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence, such as acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(f) *Termination for the Government's convenience*. The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the

notice of termination, plus reasonable charges that the Contractor can demonstrate to the satisfaction of the Government, using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred that reasonably could have been avoided.

(g) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(h) *Warranty.* The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.
