PURCHASE DESCRIPTION

Statement of Need and Purpose:

The Section on Behavioral, Neurocircuitry, and Pain under the National Institute of Complementary and Integrative Health would like to purchase the Sensory Sentinel Environmental Monitoring device. This device continuously monitors, and data logs the environmental variables such as noise & vibration, temperature & humidity and light changes along with, staff activity in the hold room. All the information from this monitoring system is critical for stabilizing environmental conditions for affective behavioral testing experiments. This device will be used for duplication of behaviors used in previous published experiments. It must function the same as the model in the animal facility for these experiments. Because we began our affective behavior research with specific environmental parameters, it is critical to the advancement of our research and the mission of NCCIH to have the same environmental parameters to maintain consistency and decrease variability in data. This will ultimately help further our mission to understand the different cell type circuits in the brain that modulate pain.

Background Information and Objective:

Generic Name of Product: Sensory Sentinel Environmental Monitoring device

Purchase Description:

These parts and services are used to purchase and install the Sensory Sentinel Environmental Monitoring device.

Salient characteristics:

To detect excessive stressors both internal and external to the lab that compromises animal welfare and research results. The following are the features useful for our experimental purposes:

- Custom filters and special microphones that will allow the lab to measure specifically what the mice is experiencing during experiments.
- The capability of the microphones to measure up to approximately 0.3 to 100,000 Hz of noise exposure data.
- For noise and vibration requirements the accelerometer need to have a sensitivity of 100 mv/g.
- Temperature to have an accuracy of +/- 0.2C, capable of operating at -4F to 140F and storage temperature array at -22F to 158F.
- Humidity range must be at 95% non-condensing.
- The capability to detect light levels ranging from 0 to 100,000 Lux.
- Must be wifi connectable to allow monitor and produce reports outside the lab.
- Must be fully mobile, allowing measurements anywhere in the lab animal spaces.
