Subject: NCI Bid Board Posting - Immunogenicity Study with BALB/c Mice

The National Cancer Institute Center for Cancer Research Laboratory of Molecular Biology (LMB) currently pursues 3 major areas of research to understand and treat cancer. One area comprises the study of antibody based cancer treatments for hematologic, liver and mesothelin based cancers. Another area is modeling of thyroid hormone based cancers. The third area focuses on basic biochemical processes of gene transcription, post-translational regulation, molecular chaperone systems that manage protein damage, and the localization and assembly of large protein structures.

LMB's mouse study will involve the injection of a biological product into the mouse and a collection of the serum at various intervals after injection. The serum will then be analyzed for levels of relevant proteins that the product was designed to stimulate, such as antibodies against certain antigens.

The National Cancer Institute Center for Cancer Research plans to purchase three samples of lambda phage to be injected into mice and the serum returned for analysis from Integrated Biotherapeutics, Inc., Rockville, MD. This is not a request for competitive quotation. However, if any interested party believes it can meet the attached requirements, it may submit a statement of capabilities. The capability statement must be in writing and must contain information and material in sufficient detail to allow NCI to determine if the party can fully meet this requirement. The capability statement must be received in the contracting office by 11:30 AM on August 9, 2024 ET. A determination by the Government not to compete this requirement based upon responses to this notice is solely within the discretion of the Government. Information received will be considered solely for the purpose of determining whether to conduct a competitive procurement.

Sole Source Justification:

This study is the continuation of previous trials that were performed by this same company in the testing of the same product. This company will be best able to replicate the conditions and protocols of the previous study since they are the original source for the previous study. To receive data consistent with the previous experiments of the same vaccine, we must send it to the same company. Without this consistency between trials, we risk erroneous statistical significance

1.0 TITLE

Immunogenicity Study in BALB/c – EGFRvIII-λ Phage

2.0 BACKGROUND

This mouse study will involve the injection of a biological product into the mouse and a collection of the serum at various intervals after injection. The serum will then be analyzed for levels of relevant proteins that the product was designed to stimulate, such as antibodies against certain antigens.

The vector of the product is a lambda phage that was engineered with an antigen attached to the D protein that forms the head of the phage. The antigen will be displayed on the phage head as a mode of delivery to the site where the antigen is needed. This product will then function as a vaccine against the antigen target.

To test the efficacy of this biological lambda-vaccine product, we need data from an animal study to see if the product is effective in mouse or if the design should be altered. The product was created by the NCI, in Dr. Adhya's lab, and to further the study of the product, we require that it be sent to Integrated Biotherapeutics to collect mouse study serum data.

3.0 TYPE OF ORDER

This is a Firm Fixed-Price Purchase Order.

4.0 SPECIAL ORDER REQUIREMENTS

4.1 PRODUCT FEATURES/SALIENT CHARACTERISTICS

The service we are requesting from Integrated Biotherapeutics is a mouse study. The company is already equipped with the proper facilities and licensing to perform animal experiments, and they are well-suited to perform the specific kind that we require for the testing of our product: injection of product and serum collection over the course of 42 days. They will not need to recruit extra equipment or provide extra training for staff to complete our order. This is a routine process that their facility is excellent at providing.

4.2 DELIVERY / INSTALLATION

The serum deliverable will be shipped back to Adhya lab, Building 37, Room 1538 at the completion of the study. The study will continue for 42 days, at which point the company will collect final serum samples and ship them back to us on dry ice along with the other samples collected over the course of the study.

4.3 TRAINING

No training requirements stated by the company.

5.0 PAYMENT

One fixed installments of 50%, the first upon signature of the quote and the second upon delivery of the serum back to us.

If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(h) *Warranty.* The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.
